Dashboard:

- Automated site contribution calculations and designation of upwind and downwind monitors with support for multiple monitors
- Live dashboard presents real-time site contribution calculations, updated every minute. Access your data anywhere, through the Aeroqual Cloud platform
- Automated mode switching between initial, 2-hour rolling and 30-minute rolling average in the event of an exceedance, when using the South Coast AQMD Rule 1466 template
- Supports 15-minute average PM and VOC contributions on a single dashboard (as required by NYS DER-10)
- See wind direction, wind speed, and the location of monitors on a site map
- Look back at historical data for a selected date range

Real-time Alerts:

- Receive SMS and email alerts if values go above user-defined trigger levels
- Create alerts on both instantaneous and average calculations, so you can act before an exceedance occurs
